## Kids Consignment 4 You Consignor Agreement

In consideration for the opportunity to participate in and profit from the *Kids Consignment 4 You Sale* (KC4YS), the undersigned consignor agrees to the following:

1. Consignor agrees to hold harmless and make no claim against Maria Hoffman, Steve Hoffman, Kids Consignment 4 You, lesser or owner of the space where the sale is held, any volunteer or paid participants in the KC4YS, or the insurer of the KC4YS for the damage, theft, or loss of any items consigned to KC4YS. KC4YS does not anticipate any thefts, damage, or loss and takes every precaution to prevent them, but occasionally these events may occur.
2. Consignor agrees to waive any and all claims for personal injury resulting from participation in the KC4YS from whatever cause either foreseen or unforeseen against Maria Hoffman, Steve Hoffman, Kids Consignment 4 You, lesser or owner of the space where the sale is held, any volunteer or paid participants in the KC4YS, or the insurer of the KC4YS.
3. Consignors will receive 65% of the sales price on items that sell. Consignors who volunteer and complete one shift will receive 70% of sales. If a Consignor signs up to volunteer and does not complete the volunteer session, Consignor will then receive only 65% of sales.
4. Consignor agrees that on Sunday, May 16th, some items may be sold for up to half of the price originally designated by the Consignor if the Consignor has marked Discount on the item's Consignor Information Tag.
5. **All goods left in the possession of KC4Y are at the sole risk of the Consignor. Consignor agrees that it shall assume and bear all risks regarding consigned goods, and will hold Maria Hoffman, Steve Hoffman, and KC4Y exempt from any and all liability. Should items be lost, stolen or damaged, Maria Hoffman, Steve Hoffman, and KC4Y are not responsible to compensate the Consignor for the items.** \_\_\_\_\_ Initial Here
6. Consignor acknowledges that he/she has read, understands, and agrees to abide by the Selection, Preparation, and Tagging procedures outlined on the Kids Consignment 4 You website. Consignor will provide only items in very good condition for sale – without holes, stains, broken or missing parts/pieces. All toys, games, and other items requiring batteries will be presented at the drop off appointment by the consignor with batteries and in good working condition.
7. KC4Y reserves the right to remove any items from the sale due to wear, poor condition, or stains. Items remaining after **May 16th at 7pm** will be donated or become property of KC4Y.
8. **Consignor testifies that he/she has reviewed recalled items on the CPSC website: [CPSC Recalls Look-Up by Manufacturer](#) and that, to their knowledge, none of the items he/she is consigning at the Kids Consignment 4 You sale has been recalled.** \_\_\_\_\_ Initial Here
9. Consignor agrees that no claims will be made against KC4Y for any discrepancies involving items placed in the sale.
10. Consignor agrees that unsold items marked with Donate on the Consignor Information Tag will be donated at the end of the sale.
11. Consignor agrees that items with no Consignor number on the Consignor Information Tag or no tag will not be sold and will be placed in a lost and found area at the end of the sale. Any items not picked up from lost and found by May 16<sup>th</sup> at 7pm will be donated or become the property of KC4Y.
